MONTHLY OVERVIEW:

Economic & Community Development continued advancement of strategic initiatives across infrastructure, capital investment, public safety coordination, and community-focused development programs.

Throughout April, the department maintained centralized oversight of grant compliance, financial reconciliation, reimbursement processing, and audit-sensitive documentation across active funding programs.

In addition to funding administration, the department supported ongoing capital project execution, infrastructure coordination, and public communication efforts, while continuing to enhance digital services, interdepartmental operations, and external partnerships.

Strategic focus remains on strengthening internal processes, ensuring compliance, improving service delivery, and positioning the City for sustained growth and investment.

KEY ACTIVITY:

- Coordinated planning, scheduling, and public communication for roadway safety improvements along S. Mack Smith Road and Belvoir Avenue, including contractor coordination and traffic control strategy

- Continued coordination of interdepartmental and external partner communication for infrastructure and development projects
- Oversaw digital engagement strategy and social media content across all City platforms

City of East Ridge Police Chief's Monthly Report

The City of East Ridge Police Department responded to a total of 1,841 calls for service during April 2026.

The department filled a total of 130 open records requests from citizens and the District Attorney's Office.

A total of 627 citations were issued from 691 traffic stops.

The East Ridge Police Department made a total of 50 physical arrests that included 75 misdemeanor charges and 27 felony charges.

The East Ridge Police Department answered 4 calls within the City of Ridgeside and conducted daily self-initiated activities (directed patrols, park and walks, etc.).

Currently, three officers are in the Field Training Program.

During April, the Parks and Recreation Department focused on spring programming operations, facility improvements, project coordination, and long-range planning for future events and capital projects. Staff supported multiple athletic programs, special events, maintenance needs, and advanced several major initiatives tied to park infrastructure and the Community Center.

- Awarded contract for Community Center roof project following Council approval
- Coordinated with East Ridge Futbol Club to support management of the Scenic City Cup soccer event
- Met with Hamilton County staff regarding next phase of park turf improvements; currently preparing bid documents
- Initiated preparation of the upcoming fiscal year budget
- Met with two new event organizers planning large-scale events for 2027
- Finalized planning and development of canoe launch improvements in coordination with GroundScapes (project completed)
- Attended Tennessee Department of Environment and Conservation (TDEC) meeting at Harrison Bay
- Participated in City safety meeting
- Completed installation of litter boom
- Attended Springvale project meetings; ongoing project management and plan review
- Continued updates and enhancements to the Parks and Recreation website
- Promoted parks and events through social media and website platforms
- Held bi-weekly meetings with Pillar Construction to receive updates on the Community Center renovation project

These events provided valuable regional exposure for East Ridge and contributed to consistent utilization of park facilities while supporting local tourism and economic activity.

Community Center Progress & Programming

- Began preparations for the 2026 Fall Festival, including reopening applications for returning vendors and developing registration materials
- Delivered a presentation to the East Ridge Optimist Club highlighting senior fitness programs
- Met with representatives from the venue, library, and Animal Services to coordinate Town Center activities and strengthen interdepartmental collaboration
- Participated in an AOA project meeting with Wallace Researchers in attendance
- Hosted the Senior Fitness Luncheon on April 22
